She is the first lady entrant in the country to do her gender proud by having rose to the position of the Managing Director of Jindal SAW Ltd. a part of the fourth largest industrial house in India, the O.P. Jindal Group, Sminu Jindal's contribution to the growth of the organization has been phenomenal.

An alumna of Shri Ram College of Commerce, Sminu Jindal went on to pursue MBA from Fore School of Management, with specialization in Finance. Her outstanding academic performance won her a Silver Medal and later on Institute of Marketing & Management bestowed upon her the Award for Excellence as top woman entrepreneur.

Ingrained in Ms. Jindal's corporate DNA is an unstinting commitment for making a difference in the lives of people with reduced mobility especially the elderly & the disabled. A wheelchair user due to an accident at a tender age of 11, she understands the negativity that come with these situations and feels the only way to overcome this is by providing independence & dignity through accessible public infrastructure & transportation systems. Through her initiative 'Svayam' she works very closely almost hand-in-hand with policy makers, govt. agencies, civic bodies, industry associations to nurture a complete inclusive ecosystem which understands, develops and maintains accessible built environment for all sections of the society.

Ms. Jindal is the driving force in the promotion of an inclusive and barrier free public infrastructure that facilitates dignity for people with reduced mobility and their active participation in the mainstream society. Her single-minded dedication to the cause has not only given it the right impetus but also influenced policymakers to incorporate steps to meet the rising demands for 'inclusivity for all'.

'Svayam' has not only been highlighting the need of accessibility in public infrastructure through undertaking access audits, write ups, sensitization workshops, focused training sessions, sustained campaigns to promote the concept of barrier free environment, but actively handholds the process of implementing access solutions suggested to the government and civic agencies at various levels.

Her visionary efforts were crowned with success when Svayam was conferred the 'National Tourism Award of Excellence' jointly with Archaeological Survey of India (ASI), for making the World Heritage Sites, the Qutub Minar and the Red Fort in Delhi as well as the Fatehpur Sikri Group of Monuments in Agra as the 'Most Accessible & Disabled Friendly Historical Monument' in 2009, 2011 and 2012 respectively.
